The price bid per hour for this Item will be utilized when **downtime** is due to County of Ulster work forces, when bridge approaches are being reclaimed, and/or when a reclaiming project is less than 4,000 square yards in an eight (8) hour day. Use of the water truck for roadway moisture content or dust control is included in the square yard cost of Item #1-RECLAMATION.
